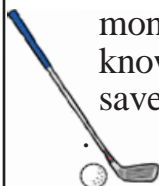

3. No, this time I mean it ... not crying wolf... its our turn for capital improvements with approx. \$500,000 slated for Rec Park South. Specifics to follow.
4. As you are aware, the green fees have gone up and as I have said before, American Golf has the option to raise the fees each Oct 1 by no more than the consumer price index as per contract with the City.... with no input from the Golf Commission.

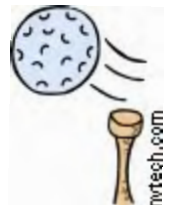
